This paper aims to illuminate the obstacles to e-learning implementation by conducting a thorough review of e-learning literature. Furthermore, these barriers will be categorized to propose an e-learning barrier framework, assisting educational stakeholders in system development and implementation.

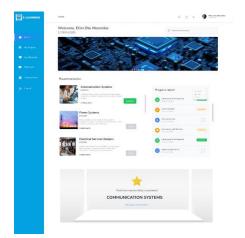


Figure 4.3: Prototype Screens for the Home Screen of E-learning Management System (E-LMS).

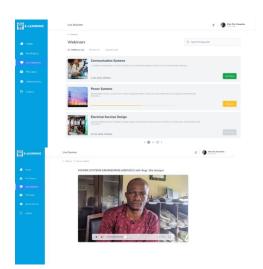


Figure 4.6: Courses on the platform Figure 4.7: Lecturer delivering lecture.

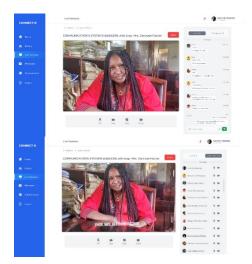


Figure 4.8: Lecturer delivering lecture Figure 4.9: Lecturer delivering lecture with students

- A student who is attending a live webinar could chat with the instructor and other students by clicking the chat button on Fig. 4.8 or 4.9.

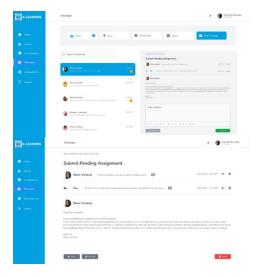


Figure 4.10: Messaging

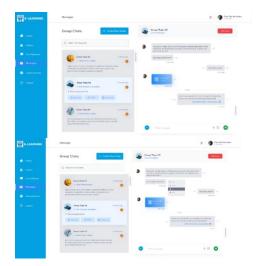


Figure 4.12: Messaging, Figure 4.13: Messaging

Fig. 4.10, 4.11, 4.12, and 4.13: These screens allow students to send, receive, and manage personal and

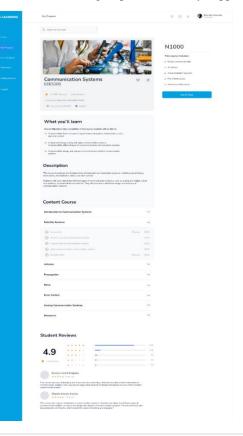
group messages. This is a great way for students to communicate with each other and the instructor, getting help with assignments, or simply staying in touch with classmates, and to ask questions and get help with the material.

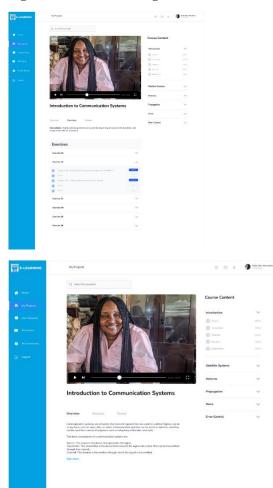


Figure 4.16: Couse Management
